The course is offered as one complete course comprising both on-site collection/testing for alcohol and drugs of abuse including breath, urine, oral fluids, hair and nails collection/testing or as an individual training course for on-site testing of alcohol (only), or for urine and/or oral fluids (only), or for breath, urine and oral fluids (only). The course includes one (1) nationally-recognised unit of competency, while students completing the hair and nails collection for testing component will also receive a *Psychemedics Corporation* Certificate of Completion and an *AWDTS* licence to conduct hair drug testing.

This course qualifies those students who successfully complete the oral fluids and/or urine collection/testing component(s) to become a Collector iaw the requirements of AS4760:2006 *Procedures for specimen collection and the detection and quantitation of drugs in oral fluid* S1.3.13 and/or AS/NZS4308:2008 *Procedures for specimen collection and the detection and quantitation of drugs in urine* S1.3.14. A Statement of Attainment will be issued to successful students.
